A. *Board Action Regarding Proposed FY2024 Budget

Kent Bultman, Director of Finance and Clark Wicks, Superintendent, will give a brief overview of school finance and its connection to the school budget. This is the time for Linda Andorf, Board President, to ask if there are any public comments per FY24 Budget.

At this time the FY 2024 Perry School Budget is being certified with a 3.0% SSA (Supplemental State Aid). PCS tax rate would be \$18.84, a reduction of 61 cents from the previous year. This is the sixth year in a row the tax rate has been decreased.

The Perry Community School District Stronger Connections Grant will be open to any public comments. A. *Approve ETS Performance System Details and Agreement for Three Years

ETS is a physical and psychological training system. The vison of ETS (Englebert Training

Systems) is to provide unmatched speed, power, deceleration, energy system development,

movement and performance mastery training for men, women, boys and girls of all activities

ranging from golf, football, wrestling, to dance and every activity between. ETS is fully committed to maximizing student athlete's genetic physical and psychological potential. ETS has trained over 2500 D1, D2, D3 student athletes as well as over 200 professional athletes. It is a "non-traditional" training system that could be a game changer if the Perry School, the community, coaches, and student-athletes are committed to the training process. Chase Lester, ETS Performance Coach will be present to answer questions. The investment for the school year (September-May) is \$28,000. The Summer Program will range from \$12,500-\$20,000, depending on participants. Participants (Student-Athletes) to pay \$25 each for the Summer Program. The Perry Youth Groups and Booster Club will partner with the school to cover the Summer Program. Student Athletes will help defer costs through a Fundraiser in the Fall. ETS has met with Board representative, coaches, youth coaches and some families. ETS started in Minnesota, has over 24 ETS Performance Centers in the Midwest. Perry Community and Perry Schools will be the first ETS partnership in Iowa.

Recommend approving the ETS Performance System Details and Agreement (3 Year Agreement) at a cost of \$28,000 for September-May and a range of \$12,500-\$20,000 for the Summer Program. The Summer Program will be sponsored by the Booster Club.

F. *Approve Resolution Authorizing the Redemption of General Obligation School Bonds, Series 2019, Dated July 23, 2019, Approving an Escrow Agenda Agreement, and Levying a Tax for Fiscal Year 2024 for the Redemption of General Obligation School Bonds, Series 2019, Dated July 23, 2019

This resolution will allow the district to execute a surplus levy resolution for the debt service fund in the amount of \$1,325,000 which will be escrowed in Spring 2024 until the June 1, 2025 call date of the Series July 23, 2019 bonds and used at that time to call the entire June 1, 2036 and June 1, 2037 of the Term Bond maturing June 1, 2039. This would be a savings of approximately \$1,325,000 to the district. President Andorf will read the Resolution. Kent Bultman will take a roll call vote of the Resolution.

G. *Approve Revisions of Board Policies 210.1-210.10

H. *Ruth Calhoun Scholarship Transfer

The Ruth Calhoun Trust was established after her death in October 1987. Her Estate established the Trust to annually loan at least annually from the net income of the Trust up to \$3,000 per year to not less than two nor more than four graduates of Perry Community School District who are enrolled (or will be enrolled at the time the funds are expended) in a duly accredited and recognized four-year college or university. Recipients of these loans have no legal obligation to repay such loans.

There has been no activity in the fund since 2008. Interest received has been accumulating over the years. The current balance as of March 31, 2023 in the RUTH CALHOUN TRUST REPAYMENT Fund is \$37,170.44, and the RUTH CALHOUN TRUST Account is \$74.06.

It is not the intent of the District to offer 'loans' through this fund in the future and would like to consolidate the two accounts into one names RUTH CALHOUN TRUST and that \$12,000 be transferred to Fund 87 as an UNEXPENDED Scholarship Fund (Principal) and that the interest earned each year be transferred to Fund 81 EXPENDABLE Scholarship Fund to be made available to graduating seniors of Perry Community School District.

This would be in line with how we have the Mary Boyer, Beasley-Mills, and Virginia O'Brien Scholarship accounts set up.

Recommend the Transfer from Fund 81 Expendable Scholarship Ruth Calhoun Trust to Fund 97 Nonexpendable Scholarship Fund in the amount of \$12,000 and also a transfer of \$2,500 to establish a PERC Account under the same name through Raccoon Valley Bank, Perry, Iowa. The remaining balance of \$22,744.50 (plus any interest) would be available in Fund 81 Expendable Scholarship Fund and known as RUTH CALHOUN TRUST Account to be used for scholarships for graduating seniors at Perry High School.
