VI. Reports

A. Superintendent Report

Superintendent Wicks will honor Troy Griffith for receiving the 2023 Tom Horn Memorial Award which is presented annually to an Iowa Pupil Transportation Association member serving in the capacity of school transportation director, supervisor or administrator. Congratulations Troy for your dedicated service. Superintendent Wicks will give updates for the start of the 2023-2024 school year.

VII. General Business

A. * Voluntary Early Retirement for 2023-2024 School Year

Voluntary Early Retirement has been offered periodically the past years at Perry Schools. It is a common practice in most other Iowa Schools. The purpose of the Early Retirement practice is to help the school system's general fund. It is not to be considered a benefit or an incentive. Voluntary Early Retirement is funded out of the Management Fund. The last time a Voluntary Early Retirement was offered was 2020-2021. The revised Voluntary Early Retirement Board Policy, Code No. 407.6 is included if the Board Approves the Voluntary Early Retirement for 2023-2024. Linda Andorf, Clark Wicks, and Kent Bultman have had conversations with staff, legal counsel, IASB, ISFIS, and other schools to understand all angles of this topic. A decision on this agenda item will allow for the school to start planning for filling those potential vacant positions.

DISTRICT GOALS:

Demonstrate growth in student learning Secure and manage financial resources responsibly. Provide each staff member with targeted staff development. Communicate and collaborate effectively with all stake-holders.

The Board will give a recommendation to offer Voluntary Early Retirement or not to offer it for the 2023-2024 school year.

The American Rescue Plan (ARP) Act of 2021 authorized emergency relief to schools
through the Elementary and Secondary School Emergency Relief fund we refer to
as ESSER Funds. One requirement to receive these funds is districts must complete
a plan called Return to Learn On-Site Plan. Perry Schools is required to review the
Return to Learn Plan every six months through September 30, 2023. In the Board
Packet is the 2023-2024 Perry's Return to Learn On-Site Plan.

C. *Approve 28E Agreement with Gingerbread Preschool for 2023-2024
